18. That no member of school managing committee is related to each other.

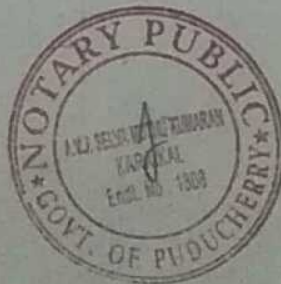
